<sup>7</sup> Transactions in the Australian dollar account are translated using the prevailing rate at the time of the transaction. Year end balances are translated at the closing exchange rate.

#### Treasurer's report

Revenue from ratings levies continued to increase in 2018, leading to over USD\$4000 in rating levy income. All oustanding levies from 2017 were collected and all levies from 2018 (save for a few year-end tournaments that will be submitted in early 2019) were collected. A number of African nations joined/rejoined WESPA in 2018 thanks to Chief Toke Aka's mid-year membership drive: please welcome Ghana, Liberia, Sierra Leone and Tanzania.

Despite a significant exchange loss due to the weakening of AUD versus USD in the valuation of the AUD WESTPAC account of USD\$850 (offsetting the previous USD\$630 gain from 2017) and a small honorarium being awarded to the treasurer (commensurate with the compensation received by the webmaster), an operating surplus of almost USD\$1900 was generated, bringing total cash reserves to just over USD\$21000.

### Auditor's Report to the Members of WESPA

I have audited the accompanying financial statements of the World English Language Scrabble Players Association (WESPA) as at 31 December 2018, and the related support documents/bank statements for the year ended 31 December 2018. The financial statements are the responsibility of the WESPA Treasurer. My responsibility is to express an opinion on the financial statements based on my audit.

This special purpose financial report has been prepared solely for the purpose of reporting to members, and is not intended to be lodged under any national jurisdiction. It has been prepared on an accruals basis and is based on historic costs. No specific Accounting Standards have been intentionally applied.

I conducted the planning and performance of the WESPA's audit in accordance with the Generally Accepted Auditing Standards. I considered the WESPA's internal control structure and system in place, in order to assess its validity and relevance to WESPA's business, to determine my auditing procedures, and for the purpose of expressing my opinion on the financial statements. I examined on a test basis, evidence supporting the amounts and disclosures in the financial statements.

I believe the audit provides a reasonable basis for my opinion.

In my opinion, proper accounting records have been kept by the Committee and Treasurer. Financial controls and principles have been consistently applied and the financial accounts are in agreement with the accounting records kept during the period under review. The financial statements present a True and Fair view of the accounts and the state of affairs of the World English Language Scrabble Players Association (WESPA), and the results of its operations, in all material aspects as at 31 December 2018.
